Ordinance No. 28 2021

**ORDINANCE CREATING AND ESTABLISHING NORWOOD FUND 2095 "AMERICAN RECOVERY ACT FUND", AND DECLARING AN EMERGENCY**

**WHEREAS**, the United States Congress recently passed House Bill 1319, "Providing additional relief to address the continued impact of COVID-19 (i.e., Coronavirus Disease 2019) on the economy, public health, state and local governments, individuals, and businesses" that has been signed by President Biden, and became Law (117-2) on March 11, 2021; and

**WHEREAS**, Section 8, Subtitle M provides that money received by a municipality under the provisions of H.B. 1319 "shall be deposited into a new fund in the subdivision's treasury to be named the "American Recovery Act Fund"; now therefore,

**BE IT ORDAINED** by the Council of the City of Norwood, State of Ohio, that:

**SECTION 1.** There is created a special fund for the City of Norwood to be known as the **NORWOOD FUND 2095, AMERICAN RECOVERY ACT FUND**. Funds received under the terms of H.B. 1319, shall be deposited into this fund, and shall be disbursed by the City of Norwood in accordance with the terms outlined in H.B. 1319.


**SECTION 2.** This ordinance is hereby declared to be an emergency ordinance and a measure necessary for the immediate preservation of the public peace, health, safety and general welfare and shall go into effect forthwith. The reason for said emergency is the need to be eligible to receive federal funds to offset expenses related to the City's response to the Coronavirus pandemic, as soon as those funds become available.
