Ordinance No. 24 2021

ORDINANCE APPROVING A ZONE CHANGE FROM THE HEAVY MANUFACTURING (M-2) USE CLASSIFICATION ZONING DISTRICT TO THE GENERAL BUSINESS DISTRICT (GBD) USE CLASSIFICATION ZONING DISTRICT, FOR THE PARCEL IDENTIFIED BY THE HAMILTON COUNTY AUDITOR AS 2692 MADISON ROAD, PARCEL 651-0041-0228-00

WHEREAS, the real property owner, HGREIT II MADISON ROAD LLC has requested a zone change for parcel #651-0041-0228-00, approximately 19.914 acres, from the Heavy Manufacturing (M-2) use classification zoning district to the General Business District (GBD) use classification zoning district; and

WHEREAS, pursuant to section 1117.06 of the Codified Ordinances of the City of Norwood, the Planning Commission conducted a public hearing at its regular meeting on April 7, 2021, regarding the question of recommending approval of the zone change referred to herein; and

WHEREAS, at the conclusion of the Planning Commission's public hearing, the Planning Commission voted to recommend approval of the zone change, covering the area provided for herein; and

WHEREAS, this Council has conducted a public hearing on May 25, 2021, as required by Chapter 1117 of the Norwood Codified Ordinances, now therefore,

BE IT ORDAINED by the Council of the City of Norwood, State of Ohio, that:

SECTION 1. This Council hereby changes the zoning district for 2692 Madison Road, Hamilton County Auditor parcel #651-0041-0228-00, approximately 19.914 acres, from the M-2 Heavy Manufacturing (M-2) use classification zoning district, to the General Business District (GBD) use classification zoning district.


SECTION 2. This ordinance shall go into effect the earliest date allowed by law.
