



Ordinance No. 10 2021

**ORDINANCE APPROVING THE FOURTH AMENDMENT TO THE DETAILED FINANCIAL PLAN FOR THE CITY OF NORWOOD, AND DECLARING AN EMERGENCY**

WHEREAS, Ohio Revised Code §118.06, which states requirements of municipal corporations in fiscal emergency, requires that the Mayor submit an amended detailed financial plan to the Financial Planning and Supervision Commission and the Financial Supervisor which must have been approved by ordinance of this Council; and

WHEREAS, the Council passed Ordinance 16-2017, which ordained the initial detailed financial plan which was approved by the Financial Planning and Supervision Commission in July, 2017; and

WHEREAS, the City's financial condition and specific needs changed, so its initial detailed financial plan was amended on March 27, 2018 by Ordinance 5-2018, amended a second time on March 26, 2019 by Ordinance 11-2019, and amended a third time on March 24, 2020 by Ordinance 20-2020; and

WHEREAS, since the City's financial condition and specific needs have changed during the past year; now therefore,

**BE IT ORDAINED** by the Council of the City of Norwood, State of Ohio, that:

**SECTION 1.** The fourth amended detailed financial plan, attached hereto as **Exhibit A**, is hereby approved; and



The reason for said emergency is the necessity for this Council to timely approve the amended detailed financial plan to comply with Ohio Revised Code §118.06(D).
