Ordinance No. 22 20 20

ORDINANCE EXTENDING THE FILING DATE OF ANNUAL RETURNS FOR TAX YEAR 2019 REQUIRED UNDER THE NORWOOD TAX CODE, NORWOOD CODIFIED ORDINANCE SECTION 182.05(G), TO JULY 15, 2020, AND DECLARING AN EMERGENCY

WHEREAS, the Federal Government has extended the tax year 2019 tax return filing deadline from April 15, 2020, until July 15, 2020; and

WHEREAS, Section 182.05(G) requires Norwood individual taxpayers to attach copies of their Federal tax returns; and

WHEREAS, Section 182.05(G)(1)(b) requires Norwood non-individual taxpayers to file their annual returns on the 15th day of the fourth month following the end of their taxable years; and

WHEREAS, the Council of the City of Norwood desires to limit the burden of the COVID-19 crisis on Norwood residents and businesses; now, therefore

BE IT ORDAINED by the Council of the City of Norwood, State of Ohio, that:

SECTION 1. The provisions of Norwood Codified Ordinance 182.05(G) governing the deadline for individual Norwood income tax returns are hereby extended for tax year 2019 to require that individual returns for tax year 2019 shall be completed and filed on or before July 15, 2020.

SECTION 2. The provisions of Norwood Codified Ordinance 182.05(G) governing the deadline for non-individual Norwood net profit tax returns are hereby extended to require that any annual net profit tax return for a non-individual that would otherwise be due between March 1, 2020, and July 15, 2020, is hereby extended to require that such return shall be completed and filed on or before July 15, 2020.


SECTION 3. This Ordinance is hereby declared to be an emergency ordinance and measure necessary for the immediate preservation of the public peace, health, safety, and general welfare, and shall go into effect forthwith. The reason for said emergency is to allow the extensions to go into effect before April 15, 2020.
