**RESOLUTION REAFFIRMING COUNCIL'S SUPPORT OF THE  
SECOND AMENDMENT TO THE MAYOR'S DETAILED FINANCIAL PLAN

**WHEREAS**, by Ordinance No. 11-2019, on March 26, 2019, this Council approved the Second Amendment to the Mayor's Detailed Financial Plan for the City of Norwood, required under Ohio Revised Code §118.06; and

**WHEREAS**, now, despite various changes to the financial situation of the City of Norwood in the intervening 15 weeks or so, as have occurred in the operations of the City of Norwood, and particularly in light of the Mayor's proposed hiring of additional fire fighters and police officers, this Council chooses to reaffirm its support of the Second Amendment to the Mayor's Detailed Financial Plan approved by this Council by Ordinance No. 11-2019; now, therefore,

The Council reaffirms its support of the Second Amendment to the Mayor's Detailed Financial Plan passed by Council on March 26, 2019, and ordained as Ordinance No. 11-2019 and subsequently approved by the City's Financial Planning and Supervision Commission, and currently in effect.
