ORDINANCE AUTHORIZING THE SAFETY-SERVICE DIRECTOR TO PREPARE AND SUBMIT AN APPLICATION TO PARTICIPATE IN THE TRANSIT INFRASTRUCTURE FUND PROGRAM(S) AND TO EXECUTE CONTRACTS AS REQUIRED, AND DECLARING AN EMERGENCY.

WHEREAS, the Transit Infrastructure Fund Program provides funding for the general construction and/or maintenance of roads, bridges, and related facilities involved in the provision of service by the regional Transit Authority; and,

WHEREAS, the City of Norwood is planning to make capital improvements to Montgomery Road and/or infrastructure; and

WHEREAS, the infrastructure improvements herein above described are considered to be priority needs for the community and are qualified project(s) under the Transit Infrastructure Fund Program; now therefore,

BE IT ORDAINED by the Council of the City of Norwood, State of Ohio, that:

SECTION 1. The Safety-Service Director is hereby authorized to apply to the Transit Authority for funds as described above.

SECTION 2. The Safety-Service Director is hereby authorized to enter into any agreements as may be necessary and appropriate for obtaining financial assistance from the Transit Authority.

SECTION 3. This ordinance is hereby declared an emergency ordinance and a measure necessary for the immediate preservation of the public peace, health, safety, and general welfare and shall go into effect forthwith, due to filing deadlines to seek funding.


